LegalWise offers a limited number of bursaries to its Members and/or their children. It reserves the right to accept or decline applications at its discretion and in accordance with its own internal decision-making process.

Instructions for submission of application forms:

Applications will only be considered if completed in full and submitted with all supporting documentation.

Please do not send original documents; certified copies are sufficient. SAPS or SA Post Office can certify your documents. Affidavits can be made at your local Police Station.

Supporting Documentation to be included with the Bursary Application Form:

- > A copy of your final Matric results, an academic transcript from your tertiary institution, together with your latest tertiary exam results for June 2015.
- > A motivation / essay on your life and why you should be selected as a LegalWise Bursary Holder on the page included (please use the "Motivation / Essay on your Life" form in Section 5).
- > Your Parent, Legal Guardian or friend may also write a letter of recommendation for you.
- Proof of income of Parent(s), Legal Guardian or Spouse (e.g. pay slip, letter from employer, sworn statement or tax return statement).
- > Certified copy of your South African ID (applicant) and that of your Parent or legally appointed Guardian.
- > Proof that you are the biological or adopted child of a LegalWise Member or under the legal guardianship of a LegalWise Member (birth certificate of the child of principal member, marriage certificate, court order granting guardianship) or a LegalWise Member yourself.
- > Confirmation from the University that you have registered for your degree course to study a BA (Law), BCom (Law), LLB or BCom (Business Administration) degree.
- > Proof of LegalWise membership

Selection Criteria

The following criteria will be strictly adhered to:

- > Bursaries will not be awarded to first year students. No exceptions will be made.
- You must have achieved at least a "C" aggregate (60 %) in your most recent year of study. No exceptions will be made.
- > You should be able to speak, read and write English and at least one other official language.
- In addition to academic achievement you should display a positive attitude and the commitment to succeed. You should also demonstrate initiative and have the ability to work in a team.
- > You should display good interpersonal and communication skills
- Shortlisted candidates will be required to go to their closest LegalWise branch for an interview before the end of December 2015.

- > Bursaries are only awarded for the year following the one in which the application was received.
- You, your Parent(s) or Legal Guardian must be a fully paid-up Member of LegalWise. This Membership must have been active for at least two years prior to applying. No exceptions will be made.
- No payment will be made in respect of studies already completed or for subjects which you failed to complete in the previous year of study.

What the Bursary covers:

- > The Bursary is a partial bursary awarded to cover registration and tuition fees to the maximum value of R25 000.
- The payment of fees is conditional on academic performance during the year as well as the timeous submission of all results and accounts to the Bursary Administrator.
- > The Bursary may be renewed on an annual basis on condition that the Bursary Holder demonstrates adequate academic performance, completes and performs adequately during their required vacation work at a LegalWise branch and complies with the terms and conditions of their LegalWise Bursary Agreement.

Bursary Obligations

- > The Bursary Holder is required to complete their studies in the prescribed number of years as determined by the University at which they have enrolled. Failure to do so may require the Bursary Holder to repay the amount of the Bursary awarded by LegalWise in full.
- Successful Bursary Holders will be required to work at a LegalWise Branch closest to them during their University vacation times. Vacation work amounts to 5 weeks per annum; two weeks during the June vacation and three weeks during the December vacation. Training will be provided and Bursary Holders will be remunerated for this time.
- > Bursary Holders studying B Com (Business administration) will be required to fulfill their vacation and service level obligation in Roodepoort, Gauteng. All travel and accommodation costs will be for their own account.
- > Successful Bursary Holders will be required to fulfill a service level obligation with the Company following the completion of their degree. This will be 6 months paid service for every year for which the Bursary was awarded.
